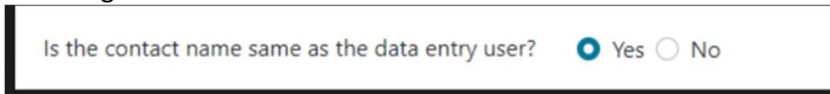


UMB Deposit Form Manual

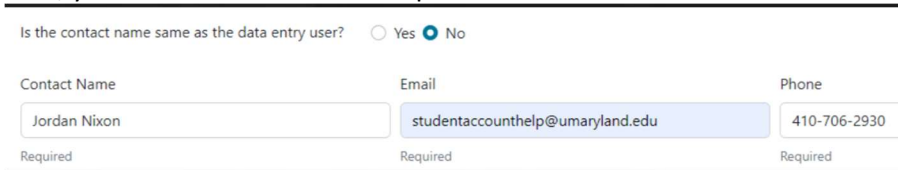

1. Log In to deposit form via SSO authentication.
Home page will list any Pending Deposit, Work in Progress, Deposited forms.
2. Select New to create a new deposit summary form.
3. Fill in all department information fields that are not pre-populated.
If the person completing the form is the contact person for the deposit, select Yes to the following radio button.

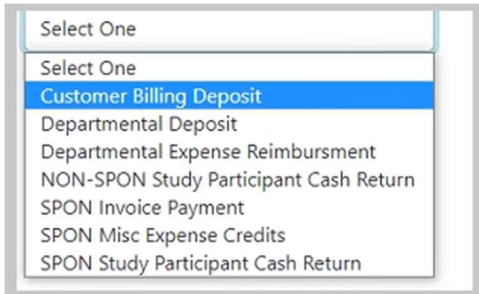

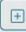

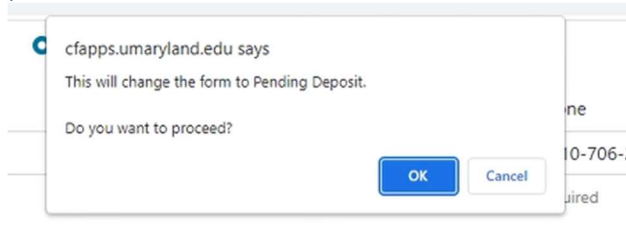
- **Customer Billing Deposit:** used for a deposit of UMB funds received for a UMB customer billing invoice.
- **Departmental Deposit:** used for UMB funds received and deposited to the general ledger. Select this option for funds that are not related to other Deposit Types (i.e., SPON, Customer Billing, etc.).
- **Departmental Expense Reimbursement:** used for a deposit of UMB funds reimbursing a non-sponsored expense.

- **NON-SPON Study Participant Cash Return:** used for returning undistributed research study participant cash to a non-sponsored source.
 - **SPON Invoice Payment:** used for a deposit of UMB funds received as a payment of an open sponsored receivable.
 - **SPON Misc Expense Credits:** used for returning funds from a vendor or sub recipient to the award.
 - **SPON Study Participant Cash Return:** used for returning undistributed research study participant cash to a sponsored source.
5. Select SAVE when done. Any updates or changes that are needed can be done after selecting SAVE, an update button will appear.
 6. Complete the Deposit Distribution section.
Depending on the deposit type chosen, the Object/SOAPF may auto populate OR you will need to enter the Object/SOAPF information. Fields that auto populate are locked from editing. The deposit form utilizes an approved list of Object/SOAPF combinations. If you receive an error message when entering the Object/SOAPF, email the University Cashier's office at universitycashier@umaryland.edu.
 7. Payment Type – Select from drop down of Check or Cash.
 8. Amount – Enter the dollar amount.
 9. Check Maker – Enter the company name or person the check is from.
 10. Customer Billing Invoice Number/Deposit Description – Enter necessary details about the deposit.
 11. Add additional lines, if necessary, by choosing the + sign.
 12. Select Submit when done.

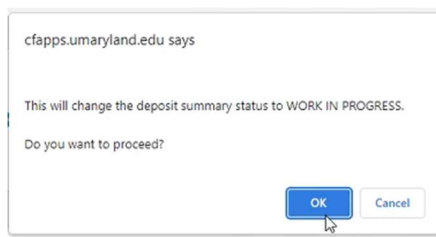

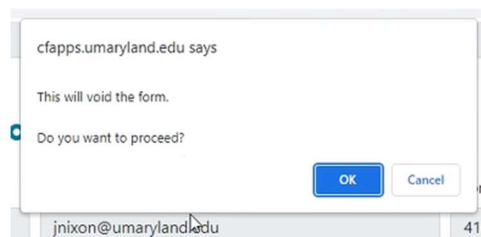

15. **Rollback Deposit** – Select to make changes to the deposit.



16. **Void Deposit** – Deletes the form completely. Voided forms will not appear in the Home screen.



17. **Print PDF** – this will change status to PENDING DEPOSIT. Print the completed form and bring to the cashier's office after making an appointment.
